**Sponsored by:** Central Carolina Gun Club.

**Who can participate:** You do not need to be a member of Central Carolina Gun Club to participate. Participants in the CMP Sanctioned matches must meet the eligibility requirements for CMP sanctioned events (<http://thecmp.org/wp-content/uploads/Affidavit.pdf>). A CMP Affidavit form is required.

Both days:	\$30	\$Free

Match Fees includes patch, year strip and Cook-out (Saturday only) and one T-shirt (w/pre-registration by Oct. 15).

Port-a-johns are available at the range.

**Entries:** Entries are limited to range capacity (20 shooters per day). Entries will also be accepted until 8:15 the day of the match if space is available.

**Rules:** All Sanctioned matches will follow the current edition of the CMP Rules. Course of Fire: All firing will be from 200 yards using the 50 shot John C. Garand Match Course "B". All matches shot concurrently, you can only shoot in one match per day.

### **Saturday Nov 7th, 2020**

**Match #1 (JCG/SPR/MVB):** John C. Garand/Springfield Rifle/Military Vintage Bolt Rifles. (CMP Sanctioned) Allowed rifles include as-issue M1 Garand, 1903 /1903A3 Springfield, M1917 Enfield, 1941 Johnsons, and U.S. Krag Rifles, and all foreign military Bolt Rifles.

**Match #2 (UMG):** Unlimited Garand allows modified versions of these same rifles per CMP rules for an Unlimited Garand Match.

**Match #3 Fun Match (CCF):** This is an "out-of-competition" match for M1 Carbines and other non-scoped WWII era rifles not allowed in matches 1 or 2. Accuracy modifications are allowed.

### **Sunday Nov 8th, 2020**

**Match #4 (JCG/SPR/MVB):** John C. Garand/Springfield Rifle/Military Vintage Bolt Rifles. (CMP Sanctioned) Allowed rifles include as-issue M1 Garand, 1903 /1903A3 Springfield, M1917 Enfield, 1941 Johnsons, and U.S. Krag Rifles, and all foreign military Bolt Rifles.

**Match #5 (UMG):** Unlimited Garand allows modified versions of these same rifles per CMP rules for an Unlimited Garand Match.

**Match #6 Fun Match (CCF):** This is an "out-of-competition" match for M1 Carbines and other non-scoped WWII era rifles not allowed in matches 4 or 5. Accuracy modifications are allowed.
